Meeting was called to order at 6:30 PM by Chair FitzGerald who thanked everyone for attending and briefed the public on the year's progress.

Judy Higgins highlighted last fiscal year's expenses and revenues as well as those planned for FY 2023-24 in the treasurer's report. Alton Bruso asked about loan RF397 2.0 which Judy said there's still a large reimbursement request still being processed by the state.

Judy then showcased how FY 2023-24's budget was largely the same as last year. There is a new line item for NEMRC software's accounts payable program. The sale of water went up to account for more users, as did insurance costs. Leeann Porto asked about the delinquent amounts which was uncollected funds. Judy Higgins replied their billing entity, Alburgh Village, hadn't had a clerk in a year and the fact SAFD2 billings didn't get processed in the schedule they had in the past. Water rates et al aren't changing for this fiscal year.

John FitzGerald motioned to approve budget as printed. Alton Bruso seconded, all in favor. So approved.

John FitzGerald nominated Shirley FitzGerald for Clerk, 1-year term. No other nominations. All in favor of Shirley Fitzgerald.

No nominations for Treasurer.

No nominations for Tax Collector. An audience member asked if this position was always vacant if it could be removed? The board would have to check their ordinance and state statutes to see if it was possible.

Gilbert Bohannon asked what leverage the fire district has on unpaid bills? They are automatic property liens.

Prudential Committee member, one 3-year term. Kathy Rochedieu nominated herself and Leeann Porto nominated Alton Bruso. Each listed their qualifications with audience members weighing in. An audience member asked if there could be a 5-member board. State statute allows for it via a district-wide vote, but not this meeting since it wasn't published on the meeting warning. A straw vote was held to gauge feelings of voting members present in regards to a 5-member board. Most raised their hands.

There was a ballot vote done which, via hand count, gave 14 votes for Alton Bruso and 6 for Kathy Rochedieu. 20 people present were registered voters of the district, two in attendance (Judy Higgins and Danielle James Choiniere) were not and did not vote.

John FitzGerald motioned to adjourn at 7:53 PM. Alton Bruso seconded, all in favor. So adjourned.
